SURCHARGE

On December 18, 2017, the Commission issued Decision No. 76515 that authorized Q Mountain to obtain a WIFA loan in the amount of \$576,776. The Company received a fifty percent loan principle forgiveness deduction which reduced the loan principle to \$288,388.

At its October 11, 2018 Open Meeting, the Arizona Corporation Commission approved the calculation and implementation of the WIFA Surcharge. The loan is for upgrading and replacing 15 portions of its water pipelines. The Surcharge becomes effective on October 31, 2018, per Decision No. 76934.

Debt Service and Debt Service Reserve Surcharges were calculated by meter size to cover a loan debt for its Phase 1 water system improvement project.

Combined, the total surcharge for all 5/8 x 3/4-inch metered customersequal \$8.65 per month.

The Debt Service Surcharge shall automatically expire at the effective date of rates in Q Mountain's next general rate case. The Debt Service Reserve Surcharge will be collected up to five years or until its next general rate case, whichever comes first.

The surcharge will be in addition to existing approved tariffs.
